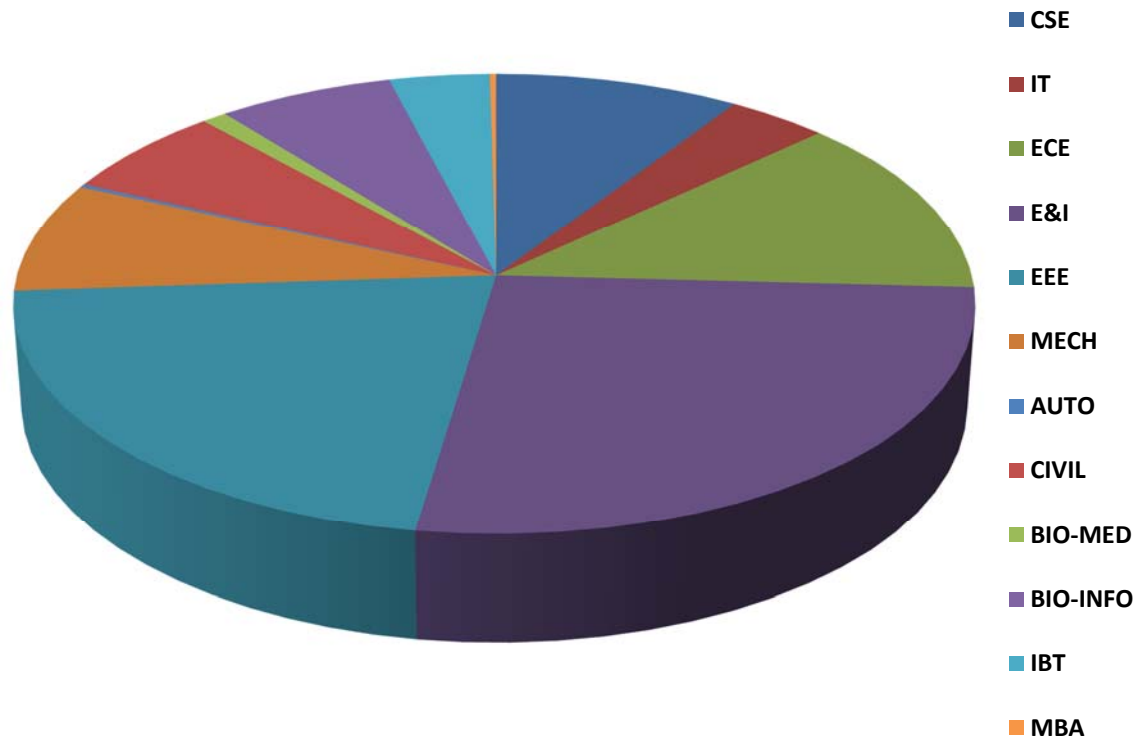
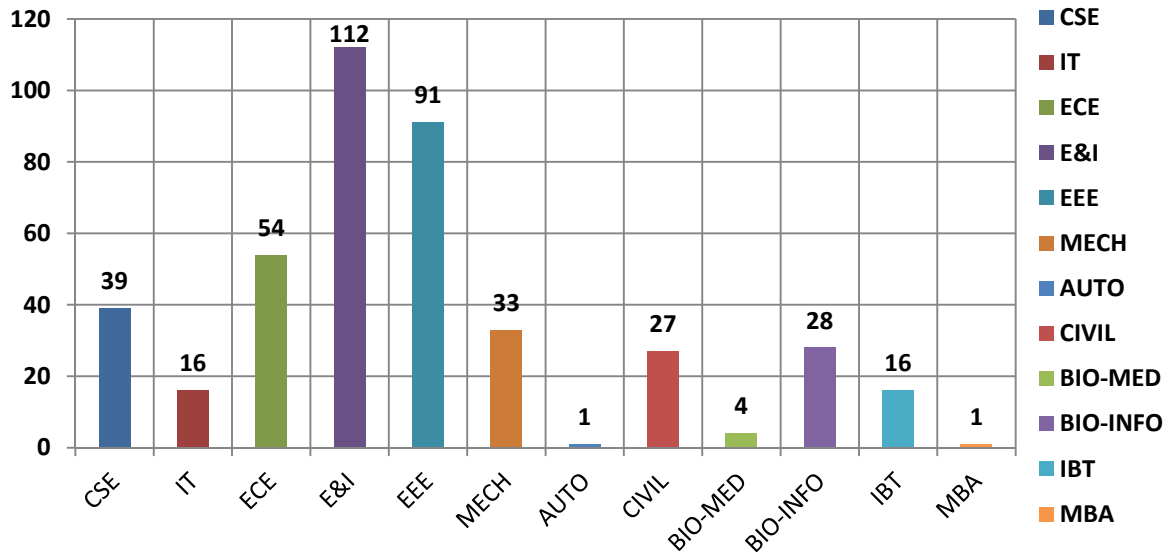

No. of Students Offered in the Year 2010-11





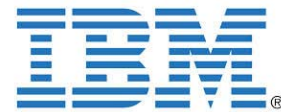
